## **New Special Needs Program**

In celebration of our long-standing tradition of supporting members and their families, Degree of Honor will launch a new Match Fund program beginning January 1, 2019.

A two-year pilot project, called the Special Needs Program, will provide up to \$500 annually in additional match funds to lodges/service clubs that sponsor a fundraising activity benefiting a member or the family of a member with special needs, or a group that supports those with special needs or their caregivers.

Additional member benefits will also be introduced in 2019. On January 1, all Degree of Honor members will be eligible for \$100 annually toward the cost of a faith-based retreat. There is tremendous value to a faith-based retreat that can only be described as life-changing, and we hope that our members will take advantage of this benefit.

## **2018 Triennial Convention**

Gathering in Milwaukee, Wis., individuals from across the U.S. fulfilled their responsibility as delegates by electing the new Board of Directors and approving Society Bylaws at the 2018 Triennial Convention. The Convention was visible proof of our members' commitment to continue to move the organization *Always Forward*.

The Convention kicked off with a celebration of the Society's mission. President & CEO, Bill O'Toole awarded the Archbishop Listecki Servant of the Poor Award to Bob Ilk, Chapter WI-52. He was presented with this award for his dedicated service to the community. A monetary donation was made in his name to the Saint Vincent de Paul Southside Meal Program in Milwaukee. Later that evening, delegates had the opportunity to

personally interact with the new Board candidates.

Friday night's celebration ended with a friendly trivia competition. Delegates were quizzed on a variety of topics and prizes were awarded to the top scoring teams.

On Saturday morning, the business session convened and delegates elected the new Board of Directors, voted to adopt changes to the

Bylaws, and received reports from Convention committees.

Bill O'Toole delivered a "State of the Society." Members of the leadership team then joined Bill on stage for a Q&A session to discuss plans for growth in the coming years.

The afternoon session highlighted two major aspects of the Society: faith and finance. Robert Powell, long-time financial journalist, provided his expertise, reinforcing the importance of saving for retirement regardless of your age. He also shared various tools and ideas on how to best prepare for your future needs. Vince Vitrano, Chair-Elect of Special Olympics of Wisconsin

### **Volunteer of the Year Awards**

#### **Michael Thompson**

As a charter member of St. Mark's U.M.C. in Evansdale, Iowa, Michael was exposed to the importance of helping others in his community early on. Over the years, Michael followed in his grandmother's and mother's footsteps by volunteering at multiple organizations. However, there's one organization that brings him the most pride ... the Honor Walk.

In 2006, Michael approached the St. Mark's Administrative Council with a request to display individual flags for Veterans, like his father and uncles, on Memorial Day along the pathway around his church. His request was approved for 20 flags and the Honor Walk was born. The Honor Walk wouldn't exist without the help of Iowa's Bravest.

Since 2006, the Honor Walk has grown to four yearly flag displays for Veterans and now emergency responders. As of November 2018, the displays included 292 Veteran flags and 94 emergency responder flags. Each flag is embroidered with the name of the veterans or emergency responders being honored. Michael requested his Volunteer of the Year \$1,000 donation be shared with the Honor Walk.

#### **Mark Minion**

Mark has a willingness to serve whenever needed. He has participated in many lodge events and volunteer opportunities over the years throughout Illinois, including music programs at nursing homes and elderly care facilities, helping families move, delivering food to the local food pantry and assisting older neighbors with lawn care and home repair. Mark also sings in the choir and occasionally substitutes as choir director. When Mark's wife experienced a shoulder injury and other health issues, he was there to lend a helping hand to her and the family business.

Mark's \$1,000 Volunteer of the Year donation will be earmarked to support the work of Mary Purvis in Guatemala.



Kaila began serving the community as a child and remains an active volunteer in West Virginia. She has served as Youth Director President for her local lodge, completed many service projects, acts as a mentor to younger children, tutors at her high school, participates in community cleanup events and helps with the children's choir.

Kaila has always had a soft spot for animals, especially at the shelter she volunteers at that helps more than 7,000 animals annually. At the shelter, she has worn many hats including help prepare vaccines, launder bedding, wash food bowls, walk the injured and rehabilitation dogs after surgery, and is co-creator of a music program to help the shelter dogs with relaxation.

It's Kaila's wish that her \$1,000 Volunteer of the Year donation be given to the Progressive Animal Welfare Society (PAWS).

### **Harvest Bars**

#### **INGREDIENTS**

#### **Harvest Bars**

1/4 cup softened butter

1 cup brown sugar

1 teaspoon vanilla

2 eggs

2/3 cup canned pumpkin

½ cup chopped dates

½ cup finely chopped walnuts

2 tablespoons flour (for dredging)

½ cup flour

½ teaspoon baking powder

1/4 teaspoon baking soda

1/2 teaspoon salt

½ teaspoon cinnamon

1/2 teaspoon nutmeg

½ teaspoon ginger

#### **Lemon Icing**

1 ½ cup powdered sugar

1 tablespoon lemon extract or cream


5 teaspoons water

#### **Bar Instructions**

- 1. Cream butter, brown sugar and vanilla together.
- 2. Add eggs and canned pumpkin, beat well.
- 3. Dredge dates and nuts in the 2 tablespoons of flour.
- 4. Sift together the remaining dry ingredients and add to the pumpkin mixture. Then add dates and nuts.
- 5. Bake in a greased 8x8 inch pan for 30 minutes at 350 degrees.

#### **Lemon Icing Instructions**

- 1. Combine powdered sugar, lemon extract/cream and water.
- 2. Add enough water to spread easily.
- 3. Once bars are cool, frost with lemon icing.
